

Tri-County Enrichment Group Rules and Regulations

In exchange for the benefits and opportunities membership in the Tri-County Enrichment Group provides for my family, I agree to fulfill the following responsibilities.

1. My spouse and I will read, sign, and agree with the registration form, the statement of faith, and the rules and regulations of Tri-County Enrichment Group.
2. Our family will pay the membership fee to Tri-County Enrichment Group prior to the due date of each semester. I understand when I sign up I am making a 1 YEAR commitment to participate in Tri-County.
3. I agree that infants and toddlers will remain in the nursery throughout the entire morning of each and every Tri-County Enrichment Group session.
4. I understand my child must be 4 years old by Sept. 1 to be in the PreK class for the first semester and by Jan. 1 to be in the PreK class for the second semester. There will be no moving from the nursery to the PreK class except on the first day of each semester.
5. I will arrive promptly (8:30 am) and ensure my children are prepared for their classes each Tri-county Enrichment Group session.
6. I understand we are to leave the church in a condition equal to or better than the condition in which we found it. I will clean my classroom, turn off the lights, and take out the garbage. I will also serve on the clean-up duty as I am assigned.
7. I, _____, agree to attend each and every Tri-County Enrichment Group session with my children (exception of sickness of my immediate family and absences that I have notified my team leader about ahead of time). I will not drop off my children if I am unable to attend. I also agree to teach a class or work in the nursery each session week. I will call the leader of my group if I am unable to attend a session for any reason.
8. I, as a teacher or helper, have the right to verbally discipline any child. If necessary, the teacher will report any difficulties to the Director immediately. This will allow the Director to discuss it with the parent of the child.
9. Clearly, our co-op requires that the children demonstrate respect of authority in order to maintain a good learning environment. In conjunction with that, the co-op also recognizes that children display a wide range of behavioral tendencies. Although the board will work with a struggling family to bring about appropriate behavior, should a behavioral problem arise that does not correct itself to the satisfaction of the board, a family may be asked to leave the co-op until such time as the behavioral problem is rectified.
10. I understand that we meet in a church and we must act in a reverent way that would be pleasing to God. There is to be no running in or around the inside of the church (except during PE). There is to be no gum and all children (PreK through 6th grade) are to wear tennis shoes. If my child does not wear tennis shoes, I understand he will not be allowed to participate in PE and, therefore, he will be sent to me with a warning note.
11. I will discuss these rules with my family and I understand if my family does not follow these rules, we can be asked to leave the group.
12. If I have any problems, question, or suggestions for improvement, I will speak with the Director or team leader.
